Paper authors are requested to submit a 250-word abstract by the date announced by the organizers. The abstract should be submitted in the form of a PDF file Content should be typed single-spaced, on A4 page size, with a 12-point font size, Times New Roman font type, in Word format

- Only selected authors will be invited to submit the full research paper within the specified time
- Full papers should be submitted in the form of an MS Word file. Content should be typed single-spaced, on A4 page size, with a 12-point font size, Times New Roman font type, in Word format. The word limit for each paper is 4,000 words. All papers should be written in English for acceptance in the conference presentation
- The full paper will be reviewed by the Editorial Board, and the comments, if any, of the Board will be communicated to the author/s for necessary action
- Authors should follow the APA citation format
- The full paper should be accompanied by a copyright form duly signed by the authors and sent to the organizers through post. The organizers will share the copyright forms with the authors once their abstracts are selected. The copyright form contains a declaration that the paper is original and has not been published anywhere
- Only selected papers will be published in the conference proceedings, and the authors will be invited for presentation at the conference. The presentation is expected to be 10 minutes long with a PowerPoint presentation followed by discussion
- The research papers must follow the best academic and research practices. Improper structure of the submissions may lead to rejection
- All accepted papers will be published in edited books with ISBN by a reputable publisher

- Those who want to submit their research work in the form of a poster are requested to submit a 250-word abstract by the date announced by the organizers. The abstract should be submitted in the form of a PDF file. Content should be typed single-spaced, on A4 page size, with a 12-point font size, Times New Roman font type, in Word format

- Authors should follow the APA citation format
- The full poster should be accompanied by a copyright form duly signed by the authors and sent to the organizers through post.
